

## **PRIVACY POLICY**

### **Information Sharing**

Intergruppo Melanoma Italiano - IMI may share your personal data with other companies or individuals not belong to IMI, provided that:

- IMI has obtained your consent. IMI must request and obtain your consent that your sensitive personal information be shared with other parties;
- we communicate your personal data to our subsidiaries, affiliates, trusted companies or individuals for the purpose of processing your personal information on our behalf. We require any parties receiving your personal data from us to conduct processing in compliance with our instructions, with the provisions of this Privacy Policy, and with all other applicable confidentiality and security requirements;
- we have a good faith belief that any access, use, conservation or disclosure of such data is reasonably necessary in order to (a) comply with any applicable law, rule, legal process or governmental request, (b) enforce the applicable Terms of Service, including detection of any violation thereof (c) verify, prevent or otherwise address fraud, security or technical issues, or (d) protect our users or the public from imminent harm to the rights, property or safety of Intergruppo Melanoma Italiano - IMI as required and sanctioned by law.

In the event of Intergruppo Melanoma Italiano - IMI being involved in a merger, acquisition or sale of all or part of its assets, it shall proceed to notify you before your personal data are transferred and become subject to different privacy policies. ### **Information security**

We undertake to ensure appropriate security measures to protect your data from any and all unauthorised access, modification, disclosure or destruction. These measures include internal controls of our data collection, storage and processing methods as well as both data and physical security measures to protect the systems on which we store your personal data from any unauthorised access. Access to your personal data shall be limited to employees, contractors and agents of Intergruppo Melanoma Italiano - IMI who need to be cognizant of your personal data in order to manage, develop or improve our services. These mandated persons are bound by confidentiality obligations and may be subject to disciplinary measures, including dismissal and criminal proceedings, should they fail to comply with these obligations.

### **Data integrity**

Intergruppo Melanoma Italiano - IMI shall process your personal data exclusively for the purposes for which they were collected pursuant to this Privacy Policy and to any other applicable Privacy Policy covering the offering of a particular service. We undertake to monitor our data collection, storage and processing methods to ensure that only personal data necessary to provide or improve our services are collected, stored and processed. We shall also take reasonable steps to ensure that the processing of personal data is accurate, complete and current. In this regard, however, we also depend on our users to update or correct their personal data if necessary.

### **Accessing and updating your personal data**

Intergruppo Melanoma Italiano – IMI undertakes to use its best effort to provide you with access to your personal data and allow you the possibility to correct any erroneous data, or delete data that are not required to be provided by law or for legitimate business purposes. Data subjects shall be required to identify themselves and indicate what data they wish to access, correct or delete before the request is granted. We are entitled to refuse to process unreasonably repetitive or systematic requests that require disproportionate technical work, would jeopardise the privacy of others, or may be difficult to retrieve (for example, requests that involve information stored on backup tapes), or for which access is not otherwise required. In any event, granting access to and allowing data correction by the data subject is a service offered free of charge unless such activity requires significant time and effort. Some of our services entail different procedures in order to access, correct or delete personal data.
